A New Department with an Old Mission

Ontario County was created by the New York State legislature on January 27, 1789. Chapter 11, Laws of 1789, created Ontario County by dividing Montgomery County, itself the result of a recent division of the old colonial county of Tryon.¹

Ontario County was the first county erected west of Seneca Lake and the Pre-emption Line. That survey line was done incorrectly in 1788 and had to be resurveyed in 1792. A line due north from 82nd mile marker on the New York-Pennsylvania border (just west of Elmira, NY), the Pre-Emption line terminated at Sodus Bay on Lake Ontario. The Preemption Line continues to figure prominently in many county documents and has been the source of many legal entanglements.

In 1789, Ontario County included all of present-day New York west to Lake Erie and the Niagara River. However, the land west of the Genesee River could not be incorporated or settled until the Iroquois nations agreed to sell their interest at the Treaty of Big Tree in 1796. Until 1824, parts of Ontario County were separated and reconstituted as other counties. When that happened, copies of the records relevant to those new counties were made for the new County Clerks. However, the original records remain in Ontario County. Consequently, very early land, court and other records that pertain to many other counties can be found in the Ontario County archives.

For many years prior to 1857, the records of the County Clerk and the Surrogate Court were kept in two "fireproof" buildings on the public square in the center of Canandaigua. After the construction of the present Court House, the records of the county were kept in the basement of that seat of justice. That basement room was also built to be fireproof. Storage in the Court House continued until the creation of the Department of Records, Archives, and Information Management Services (RAIMS). For many years, the Court House records storage area was

known as "the dungeon" by researchers. Many county records were unsorted, stacked in crates, and forgotten. In many cases, they were physically inaccessible. It has been nearly 25 years since RAIMS was created, yet many Nineteenth Century records rescued from the old storage rooms are still being sorted and processed. Many important discoveries are still made.

The Ontario County Department of Records, Archives, and Information Management Services (RAIMS) was created on February 8, 1990 (Local Law 2). That year, the Board of Supervisors voted to separate RAIMS from the office of the County Clerk. Their action was in response to state legislation reforming and prescribing new practices in records management. The current records center was built in 1988 and enlarged in 2007.

Getting to RAIMS

The Ontario County records center is located on the office complex off County Road #46 in the Town of Hopewell. Its mailing address is: 3051 County Complex Dr., Canandaigua, NY 14424.

Visitors coming from the west on the New York State Thruway (I-90) should exit at the Canandaigua Exit (#44). Follow NYS Rt. 332 into Canandaigua and continue south on Main Street. Turn left on Phelps Street (by the Fire House). Phelps Street becomes County Road #46. After crossing Smith Road, watch for the entrance to the county office complex on your right. Follow the signs to RAIMS.

Visitors coming from the east on the Thruway (I-90) should exit at the Manchester Exit (#43). Follow NYS Rt. 21 south toward Canandaigua. At the intersection with Hanna Road, turn left. Make a quick left onto County Road #4, then another quick right onto County Road 10 (Town Line Rd.) At the intersection with County Road #46 (4-way stop), turn left. After crossing Smith Road, watch for the entrance to the county office complex on your right. Follow the signs to RAIMS.

Visitors coming from Geneva on routes 5 and 20 should turn right on Freshour Road. Turn left at County Road #46. Turn left into the County Complex and follow the signs to RAIMS.

Open Records Available for Research

All of the public records of Ontario County are available for the use of the public. However, there are restrictions provided by various statutes.

The restrictions vary according to specific provisions of law and are not often changed. Challenges to those restrictions must be filed with the appropriate court.

By law, restrictions apply to the records of adoptions (permanently restricted); divorces (100 years); inquests (permanent); and the records of veterans (1917 to date restricted to family, funeral directors and veterans service officers).

The New York State Health Commissioner's Administrative Rules and Regulations provide that marriage and death records must be at least 50 years old before they are released. Birth records must be on file for at least 75 years, and the person to whom the record relates must be deceased, for information to be released. These time periods can be waived if the applicant is a descendant or has been designated to act on behalf of a descendant of the person whose record is being requested. By the Health Commissioner's rules, a descendant is a person in the direct line of descent. Applicants for birth, death, and marriage records must supply documentation of their relationship to the subject of the records. Only a few marriage records are located at RAIMS. They cover the period 1908-1935. RAIMS does not have custody of any birth or death records and cannot certify the marriage records it holds.

In addition, the availability of public records is governed by retention schedules published by the New York State Archives. Generally, the records used by academic and family history researchers are retained permanently. All records dating from before 1910 are considered permanent. A fire in the state capitol in 1911 resulted in the destruction of many records kept in the state archives then located there.

Vital Records

RAIMS does not have the authority to provide certified copies of any record. Generally, those must be obtained from the department or agency that created the record. The requirements for certification of records are established by state law.

For birth, death and marriage records, contact the city, village, or town clerk (or registrar) where the record was made and event took place. Marriage records are available from the Town or City Clerk of the municipality where the Marriage License was issued. That may be some

distance from the place of the actual marriage. It is rare for a municipality to have birth, death, or marriage records for any period prior to 1882. RAIMS holds very few vital records.

During the period 1847-1849, New York State asked district schools to record vital records. RAIMS does have some of those records for the Town of Canandaigua. The Victor Historical Society holds the early vital records recorded by schools in that town.

The New York State Department of Health can also provide certified records to those eligible to receive them.

Non-governmental Records and Manuscripts

The mission of RAIMS is to serve the records management needs of the government of Ontario County, its Board of Supervisors and residents. There are several historical societies around the county that are chartered by the state Board of Regents to collect, preserve, and make available non-government records, manuscripts, artifacts and historical information. For those reasons, and to preserve adequate storage space, RAIMS does not collect or make available genealogies, old newspapers, cemetery readings and records, images, family files, or published documents. However, there are rare exceptions. Those are made in the interest of better interpretation of the official records found at RAIMS. As a general rule, the Ontario County RAIMS holds only records generated by the government of Ontario County. RAIMS holds are a very few records generated by the state of New York and by the US government.

From 1863 to about 1945, the Ontario Children's Home (still a charitable foundation) operated an orphanage in Canandaigua. It was never, at any time, affiliated with the government of Ontario County. Many years after the orphanage closed, its records were turned over to the Ontario County Historical Society, a private, not-for-profit museum and research center at 55 N. Main St., Canandaigua. Information regarding the orphans there can be obtained from the museum. Since it is not from government records, that information is not restricted. RAIMS does hold microfilm copies of the records, 1863-1932.

Fees

The copy and other fees charged by RAIMS are established by local law or state statute. The research and retrieval fee for local and family history research was established by Board of Supervisors Resolution 432-2002, effective January 1, 2003.

Researchers working at RAIMS pay only a 50 cent fee for each page of each document copied. All copying must be done by RAIMS staff.

Requests under the state Freedom of Information Law (FOIL) are generally not necessary local family history researchers. The fee for a FOIL request is 25 cents for each photocopy. That fee will change periodically.

Research services are provided by the RAIMS staff for requests received by mail. No research requests can be accepted over the telephone or by email. While no fees are charged to in-person researchers, the fee for mail-in research requests is \$40.00 per hour, chargeable in half-hour increments.

Postage is charged based upon the weight of the material mailed.

FAX charges are \$1.50 for local calls, plus \$1.00 per page. \$3.00 is charged for long-distance transmissions, plus \$1.00 per page.

A Word about Record or Accession Numbers

The records of Ontario County are not assigned group or series numbers. They are retrieved by title, not by number, a system common in county records centers. The numbers that sometimes appear on rolls of microfilm are vendor designators indicating the year and order of production. Those vendor and production designators are not included in this guide to avoid confusion.

Records Groups and Series Open and Useful to Local and Family History Researchers

Records of the County Clerk

The records of the County Clerk include those records the Clerk is charged with recording and maintaining in accordance with the state constitution. Records generated by many county offices are kept by the County Clerk. While RAIMS is now a separate county department, it was originally part of the County Clerk's office. Records kept by the Clerk also include local municipal records turned over to the clerk for safekeeping and retention. Some federal records are kept or recorded by the County Clerk. Among these are the census records and military discharges.

Assessment Rolls (1790-1993)

From the earliest days of county government in New York, the assessment of real property values has been a town ("township") responsibility. County real property taxes are based on the assessments made by town assessors. The assessment rolls compiled in the towns were often turned over to the County Clerk in the 19th Century and continued to be turned over to the county on a regular basis in the 20th Century. The assessment records held by the County Clerk are in the custody of RAIMS and are open public records. They are often useful for establishing the age of buildings since deeds usually do not mention specific structures, but sudden rises in assessment are sure indicators that a new building has raised the value of the land. Assessment records, combined with deeds and mortgages, often provide a clearer picture of economic growth and government functions than do any of those documents alone.

As time passes, RAIMS will take custody of more assessment records. Those now kept at RAIMS are found on the following microfilms. There is no index to assessment records.

Census Records 1790-1930.

Both the state and federal census records are considered part of the County Clerk's record group. They are shelved in the main research room at RAIMS and are completely open.

Early state and federal census returns include original townships later divided. They also include in Ontario County returns townships that became part of new counties as they were erected by the state legislature. Two reference books are useful is sorting out the dates and shifting boundaries of regional counties and townships. Both references are available at RAIMS.

Federal Census records:

The first federal census was taken in 1790 and included Ontario County, then much larger. As each decennial census was taken, more

information was included. By the mid-19th Century, census information included information on children, borders, occupations, birthplace, country of origin, and race (white, colored, mulatto). The 1930 census has recently been released by the federal government.

Jail Inmates

Among the County Clerk's records is a small series of file folders containing the **List of Prisoners in the County Jail**, **1815-1853**. These lists of inmates are not all-inclusive for the span of years. Lists of prisoners can also be found in the original state and federal census books available for use in the research room at RAIMS.

Land Records (1789 to 2002)

The recorded land transactions for Ontario County are part of the extensive collection of deeds. The deeds were originally copied into the *libers* in the Clerk's office when it was convenient, or when a record was needed.

From 1789 to 1824, there was no requirement that deeds be recorded with the county clerks. After the latter date, virtually all deeds are recorded. Unfortunately, that means that there is sometimes no

public record of a sale that almost certainly happened. That also means that periodically, a researcher may bring in a valid deed that cannot be found in the clerk's records. In the extreme eastern part of the county, where there were conflicting claims by Phelps' and Gorham's syndicate and the New York Genesee Land Company ("Lesees" repudiated by the state legislature in 1789), a perfect title to certain parcels does not extend back to the creation of the county. Fortunately, those cases are few.

All deed books (called *libers*) with transactions prior to 2003 are held at the RAIMS records center. All of the newer books are held in the open public stacks in the office of the County Clerk at 20 Ontario Street in Canandaigua. The deed books held at RAIMS are also available on microfilm. Digitization of this record series began in 2000.

Deed books #1-1007 (1998) are available on microfilm at RAIMS. Starting with deed book #896 16 mm microfilm was used. The microfilm readers at RAIMS will accommodate both 16 mm and 35 mm rolls. At the present time (2009) a few deed book is missing from the series on microfilm, #844-846; 905. Future plans include digitizing the entire series of deed books. A RAIMS volunteer is currently entering the Grantee and Grantor indexes into a consolidated database. Deed books up to #1027 are available at the office of the County Clerk and more will be created in the future.

It should be noted that there was no requirement to record deeds in the County Clerk's office prior to 1824. Therefore, some legitimate transactions can not be found in county records.

There are separate index *libers* and microfilm reels divided by Grantee (buyer) and Grantor (seller).

Prior to using any deed index, the Lusk index⁵ must be consulted. That index requires the reader to use the first three letters of the subject's last name to find a page number. That page number is the number in the deed index where the name should be found. The deed index (Grantee or Grantor) will then provide the *liber* and page number for recorded deeds. Some microfilm index reels contain images of the Lusk index pages.

Lis Pendens

A Lis Pendens record is a public notice filed in the County Clerk's office indicating that certain real estate is the subject of a possible law suit. By filing a Lis Pendens notice, anyone who purchases the property takes it with full knowledge of any claims in the pending suit.

Lis Pendens notices are filed in a separate series of records recorded in Lis Pendens libers. RAIMS holds Lis Pendens records for Ontario County in two forms; bound volumes and microfilm.

However, those maps provide valuable information on the location, size, and construction of buildings inside the corporate limits of cities and villages. They generally cover only the main commercial districts. The following microfilm copies of Sanborn maps are found at RAIMS.

Of the hanging wall maps, only a copy of the 1859 map has been microfilmed. That copy was already cut up by township.

Most of the hundreds of maps housed at RAIMS are found in the map cases in the map room. They are accessed by staff only. Among them are survey maps produced by local surveyors and filed with the County Clerk in connection with construction or land transactions; federal Geological Survey Maps; subdivision maps; assessments maps; etc. There is a list of maps is arranged by map case drawer. That 13 page "List of Maps" is available on request in the research room at RAIMS. The maps are many and varied and cover a variety places and purposes.

In addition, there are more than 29,000 maps, mostly surveys that are still held in the County Clerk's office in the City of Canandaigua. RAIMS does not have the consolidated index to those maps. The bank of 15 file cabinets housing those maps in individual folders can be accessed by the public and the Clerk's staff will assist.

At the present time most of those maps are on microfilm.

At the County Clerk's Office there are several bound index books for maps. Those books primarily cover maps recorded with the County Clerk to the mid-20th Century. Useful map index books at the County Clerk's Office include:

Marriage Records (1908-1935)

Normally, marriage records are held by the clerk of the municipality (City, Village, or Town) where the marriage license was obtained, rather than where the marriage took place. However, Ontario County holds the records of marriages dating from 1908-1935. The county holds both marriage licenses and marriage certificates for the period. Availability of these records is governed by the regulations of the state Department of

Health and the privacy law. Since they are all over 50 years old, they are open to the public.

The marriage records are indexed by bride and groom. While marriage records are indexed in the front of each book of records, there is a consolidated computerized index produced locally and available only by request to RAIMS staff.

Miscellaneous Records (1789 to date)

The Miscellaneous Records of the County Clerk are a treasure trove of local and family history information. As the name implies, these records date from the creation of the county in 1789 and continue to the present. They are an open public record category. However, through the mid-20th Century, the Miscellaneous Records included some information that is now restricted by law, including military service records and adoptions. Where that information in recorded within the series it will be shielded from view and use by RAIMS staff.

In their original format, the Miscellaneous Records are found in a series of books bearing alphabetic designations (A-O), 1789-1992.

The entries in the Miscellaneous Record books are indexed chronologically. The index to each book is divided into sections according to the first letter of the person's surname. Miscellaneous Records typically include sworn affidavits, firemen's exemption certificates,

appointments to various minor offices, and other legal notices that were not clearly to be recorded in any other series.

The <u>original bound books</u> (*libers*) of Miscellaneous Records remain in the office of the County Clerk. However, the <u>microfilmed records</u> are included in the holdings of RAIMS. Photocopies of the indexes to each book are available at RAIMS. A member of the staff can retrieve them from the file cabinets in the research room. There are no microfilms of the index volumes.

Military Records

Miscellaneous Collection of Military Records

The collection of early military records of Ontario County consists of miscellaneous officers' commissions; Civil War bounty bond records; pay records for the Rochester militia ordered to Canandaigua to quell a feared draft riot in 1863; miscellaneous discharge certificates and other records found loose among the records of the County Clerk or contributed by residents and researchers. The collection is not restricted to the 19th Century. Papers relating to the support of Canandaigua and Geneva armories are included.

There are a few militia <u>commutation tax records</u> listing those who paid the commutation tax levied by the state on those who requested excusal from militia service, primarily on religious principle. The state constitution still considers all able-bodied male citizens between 18 and 45 years old to be members of the state militia. In the early 19th Century, all those men were officially organized into regiments by county and were required to turn out for drills twice a year. Quakers in particular objected to this service in the militia.

Within this mass militia, uniformed and disciplined units were formed. They became the modern National Guard. Uniformed companies were formed in several communities. Their records are found in the Adjutant General's records at the New York State Archives. A few militia unit muster rolls for the 1850s and 1870s are found in the military record collection at RAIMS.

In 1860, the office of the Adjutant General of New York compiled the <u>claims</u> it had <u>received from militiamen called out to serve in the War</u>

of 1812.6 Many of them had never been paid for their food, horses, and other person equipment used during the war. The compiled claims have been reprinted by Genealogical Publishing Company and are available in book form at RAIMS.

Petitions from soldiers seeking pensions for service in the War of 1812 can be found in the miscellaneous collection of military records.

Registration oaths and lists of registrants for Selective Service in 1917, as well as for those taking the registrations, can also be found in one box of miscellaneous military records.

The Adjutant General's claims book should be used with caution. The claims are not strictly in alphabetical order. Also, the addresses listed are often the agents (usually attorneys) of the claimants, not the claimants themselves.

The Military Records held by RAIMS are located in various bins, boxes, microfilms and bound books. Few of these records have been microfilmed or formally accessioned. Therefore, there are no accession, bin, series, or item numbers assigned to them at this time. They have not been microfilmed.

Soldier Discharges (1917-Present)

Chapter 214, Laws of 1920 provided for the voluntary recording of the honorable discharges of the veterans of World War I. In New York, veterans' military records were generally recorded in the "Miscellaneous Records" kept by County Clerks until World War II. For the first time, this law included the date April 6, 1917 as the starting date for recording veterans' records.

Chapter 332, Laws of 1942, and Chapter 313, Laws of 1943 offered World War II veterans the same opportunity to have their discharges recorded by County Clerks.

In 1950, the New York State legislature passed what became Section 250 of the state Military Law. That statute provided for the continued recording of military "discharge" documents (issued after April 6, 1917, the date of American entry into World War I) by county clerks, free of charge. The record made was considered a benefit to veterans for their personal use.

In 1968, as a result of commercial abuse of some veterans' records, the state legislature passed Section 79-g of the state Civil Rights Law. By that statute, veterans were given "the right to direct the county clerk to keep such paper sealed and confidential." Upon the veteran's request, the county clerk could no longer make the service record available to the public. However, in the absence of a specific request to seal the veteran's record, public access was permitted. That opinion was confirmed by a 1994 advisory opinion provided in a letter from the Executive Director of the state Committee on Open Government.

Between 2002 and 2004, several breeches of security resulted in threats of identity theft to millions of veterans nation-wide. In 2004, the Attorney General's office concluded that previously filed certificates were vulnerable to improper use unless veterans were made aware of their rights and took action to have their records sealed.

Chapter 298, Laws of 2005 closed all veterans' records dating from April 6, 1917. Access is restricted to parents, spouses, dependents and children of the veteran as well as county Veterans Service Officers, funeral directors, and the federal Department of Veterans Affairs. The 2005 statute as been interpreted to restrict even the disclosure of the existence of a record.

Fifteen libers (books) containing veterans' discharge information, often photo copies of military discharges and reports of separation, are held at RAIMS. Veterans' records filed after 1960 are still in the direct custody of the County Clerk. The following books are held by RAIMS but are closed by state law:

Ontario County. Soldier Discharges. Books 1-14; 6A.

Although these *libers* contain discharge from World War II to the late 20th Century, a few earlier discharges are included.

Each liber is separately indexed in the front of each book. Names are separated alphabetically, then listed in chronological order.

Many veterans' records dating from World War I can be found in the Miscellaneous Records of the County Clerk. Although that record series is open and public, the discharge records included within it are restricted by law. There are also a handful of discharges for the Civil War and Spanish-American War recorded in the Soldier Discharge books.

All requests for access to post-1917 veterans' records and record books must be made to the Ontario County Clerk.

Pre-World War I Military Census

In preparation for the eventual use of Selective Service (the draft) in World War I, the New York State legislature called for a special census of men of draft age in 1916.

Available on microfilm this special census lists all males between 18 and 45 years old by municipality. It provides their residence address, their occupation, and their age. The 1916 military census also reveals any prior military service. It is particular interest to family historians because it cites immigrants' foreign service to Italy, France, Great Britain, and other nations.

1917-1918 Draft Registrations

Available only on microfilm, these records consist of the registration cards completed by Selective Service registrars during World War I. The cards are arranged alphabetically. There are two groups representing those men registered at the Geneva draft board and the Canandaigua draft board. While men generally registered according to the part of the county in which they resided, the divisions are not clear. A researcher looking for the name of a probable soldier should check both board registration groups.

The content of the registration cards changed slightly with each of the three required registrations. All of them provide a current address, parents' names, and the occupation of the registrant. On some cards, the lower left corner is clipped. That was the official notice that the registrar considered the young man to be "colored."

It should be noted that these cards include all young men registered for the draft in Ontario County. It therefore includes many young men who were never in military service. These records are copies of those held by the National Archives. The following records are available on microfilm at RAIMS. They are arranged alphabetically by draft board and are not indexed.

World War I Rosters

In 1919 the New York State legislature asked each municipality to appoint a historian charged with collecting information on the war effort. In Ontario County, that resulted in the compilation of rosters of those who served in the military services during the war. The Ontario County Historical Society, a private museum located near the Court House, was asked to collect the roster information for the Board of Supervisors. It should be noted that the information was self-reported by military personnel, close relatives, and others involved in the war effort. The rosters are not an official record and the rosters for several municipalities are now missing.

The original rosters consist of forms completed by respondents and held in loose-leaf binders. Rosters exist for the Towns of East Bloomfield; Farmington; Geneva; Manchester; Phelps; Gorham; Naples; Richmond; South Bristol; Seneca; Victor; and West Bloomfield. There is also a roster for the City of Geneva. Each roster page provides roughly the same information found on official military discharge papers.

One unique aspect of the World War I Rosters is that they include service records for individuals who worked for the Red Cross, the Salvation Army, and similar organizations. For that reason there are roster entries for many women. The rosters also include information about those who served in Allied military services.

In addition to the original roster notebooks, the rosters are available on microfilm and scanned onto Compact Discs. See the following:

Mortgage Records (1789-1947)

Mortgage contracts have been recorded by the County Clerk since 1789. Mortgage records are indexed by mortgagee (the lender) and by Mortgagor (the borrower). Mortgage records, like deeds, are grouped chronologically in a series of *libers* (books). However, mortgage record searches require consultation in an index prior to accessing the books (or the microfilms). Therefore, only indexes are listed here.

The Lusk division table, used for land records, is also used to locate names in the mortgage records indexes.

Chattel Mortgages

Chattel mortgages were made using personal property, rather than real property, as collateral. They are particularly good sources of family and social history. Of course, chattel mortgages reveal only those valuable pieces of personal property subject to the mortgage.

Poor House Records

The record books for the Ontario County Poor House are kept at RAIMS for the dates shown. Additional information on the operation of the Poor House can be found in the annual "Proceedings of the Board of Supervisors." In later years, the Poor House was known as the county home. Its successor is a skilled nursing facility known as the Ontario County Health Related Facility.

The original poor farm occupied the land now used by the county office complex, including RAIMS, in the Town of Hopewell. In 1824, the state legislature passed "An Act to Provide for the Establishment of County Poor-Houses." The Ontario County Board of Supervisors purchased the land in Hopewell for use as a poor farm in 1825. The farm provided income for the county, work experience and sustenance for inmates of the jail and poor house from 1826 until its closing more than a century later.

Court Records

The Ontario County records center holds a variety of historical court records. Most of them are unprocessed for research at this time. Many of them are the records of courts that no longer exist since they were eliminated by one of the revised state constitutions in the 19th Century. They are almost entirely unindexed.

The following court records may be useful to family and local history researchers:

Surrogates Records

The records for the Surrogate's Court in Ontario County virtually complete and open to the public. They consist probated wills and associated papers including court orders, inventories. estate letters testamentary, and other documents needed to close out an estate. Thousands of estate files are kept in file folders and archival boxes. Researchers access the records of the Surrogate's Court by using an index.

Under the present Unified Court System in New York, the records of the Surrogate's Court are considered state records. They are kept at RAIMS by agreement with Ontario County.

Gathered and Contributed Records

Some records of the courts and the County Clerk have been gathered and microfilmed together on one or more rolls. They are otherwise unrelated as to record groups and series. Some are not even government records by are kept by RAIMS as a convenience for research. This has often been done by outside agencies for a shared purpose. The following microfilm rolls may be of use for family and local history research.

Ontario County Cemetery Records. 1 roll. 35 mm. Diazo. [Microfilmed by the LDS Church.] [Many of the entries on this microfilm are not records. They are readings from various cemetery visits around Ontario County. Organized by towns, they provide tombstone information, primarily, and often do not provide information on burials where the stone is gone or where there never was a stone. The most complete and updated list of cemetery readings is available at the Ontario County Historical Society in Canandaigua.]

First Congregational Society of Bristol, 1801-1913. 1 roll. 35 mm. Diazo. [Microfilmed by LDS Church.] [Contains the records of the defunct Bristol Congregational Church. A large number of microfilmed church records, from active as well as defunct churches, are available from the Olin Library, Cornell University.]

Looking to the Future

The Ontario County Department of Records, Archives and Informatin Management Services continues to make records available that have not been useable before. The nearly 170 year backlog of unprocessed records has been stored in dispersed locations and is slowly being processed. Suggestions for priorities in processing historical records are welcome.

RAIMS staff will also continue to monitor records disposition under the State Archives Disposition Schedule to ensure that records of enduring value, which might otherwise be eligible for disposition, are maintained at RAIMS.

As records are sent to RAIMS for storage by the departments of county government, the microfilming and scanning programs will continue. Using new technology, RAIMS has entered into pioneering arrangements with Kirtas Technologies for the scanning of records. Where possible optical character recognition will be employed to improve the efficiency of searching.
